



ANNOUNCEMENT OF NEW WATER CHARGES FROM 1/1/2023

Dear consumers,

From 2010 until today the Water Board of Larnaka has maintained a stable tariff policy without increases and in 2019 it has even proceeded with a reduction of all water charges by 5%. The Board's new tariff policy, applicable from 1 January 2023, aims at a fairer distribution of the associated costs amongst the different categories of consumers, ensuring the recovery of water supply costs from all levels of consumption and without one tariff subsidizing the other, applying in this way the Tariff Policy of the state and the guidelines of the European Water Framework Directive.

Commercial and Industrial consumers, who belonged to Tariffs B and C, will now be subject to a new common Tariff with significant savings. The Board's new water charges are as follows:

Transfer Fees and Owner's Guarantee

The collection of transfer fees of €10,50 and the collection of guarantees from owners is abolished, except in the case of common areas which remains €250,00.

Tenant's Guarantee (Remain the same)

- Household Tariff and Vulnerable Groups €100,00
- Commercial and Industrial €500,00

Reconnection fee

- within normal working hours the existing fee increases from € 25 to € 35 (plus V.A.T.).
- for non-normal working hours the existing fee increases from € 45 to € 55 (plus V.A.T.).

We urge consumers to settle their bills in a timely manner. If for any reason this is not possible, consumers should inform the customer service department in time so that a settlement can be made in order to avoid disconnection of the water supply (tel. 24200500 option 1).
